## CAREER SUMMARY:

**AREAS OF CONCENTRATION:** Painting, Drawing, Sculpture, Art History and Museum/Gallery Management.

**EDUCATION:** I've studied painting at three different institutions; University of Iowa, University of Northern Iowa and University of Minnesota. I hold an MFA in Painting and Drawing, with a minor in Art History, from the University of Minnesota, and a BA in Studio Arts, with a minor in German, from the University of Northern Iowa.

**TEACHING EXPERIENCE:** Two years at the University of Minnesota where I taught Beginning Drawing to both majors and non-majors, supervised the student gallery and organized a field trip to the Art Institute of Chicago; nine years at The Minnetonka Center for the Arts offering several classes in Painting and Drawing and where I also served on the gallery committee; six years at the Edina Art Center teaching several courses in Painting and Drawing; a Drawing Workshop at the Minneapolis College of Art and Design; a Sculpture Apprenticeship program at the Lulea Tekniska Universitet, Skelleftea, Sweden; several classes at The Minneapolis Institute of Art on the History of Painting Materials and Techniques; and an Art Survey class at The Museum of American Art. Currently I teach adult level Painting and Drawing in my private studio where I've been doing so for the past fourteen years.

**CLASSES AND WORKSHOPS:** Painting (all levels), Drawing (all levels), Drawing with Color, Pastel, Life Drawing, Figurative Sculpture: Modeling to Resin Casting and a series entitled "Art History in the Studio: A Survey of Painting Materials and Techniques", taught in four sections: "Medieval Manuscript Painting & Gilding", "Renaissance Painting techniques", "Baroque: The Venetian School" and "19th Century Pigments, Pallets & Painting Materials".

**PROFESSIONAL HIGHLIGHTS:** I am currently a full-time painter and sculptor and have been for over 17 years. Highlights include projects with the following institutions: The Smithsonian Institute National Building Museum and the Phipps Center for the Arts, Disney, Animal Planet Television, Paisley Park Studio (Prince), The Mayo Clinic and Children's Hospital of Minneapolis. Of particular note was my work with Dayton's/Macy's where I assisted in the design of 25 large-scale narrative installations, (13,000 square feet), was lead sculptor and directed the creation of approximately 1100 sculptures over a 16-year period. I've collaborated with such notables as author Tomie dePaola, Licky Dahl (for whom I designed sculptures permanently on display at the Roald Dahl Museum in Buckinghamshire, England) and Sesame Street's Jim Martin and Tim Lagasse. I have work in over 40 public collections and have been featured in several media outlets including KARE 11, Minneapolis Star Tribune, St. Paul Pioneer Press, FM 107.7 Radio "The Ian and Marjorie Show" and Midwest Home Magazine. I have received grants and awards in juried competitions through the years, most recently "Best of Show-Painting" at the national juried Uptown Art Festival in 2008. I am currently represented nationally by several galleries including Aesthetics, Inc. in San Diego, CA and American Art Resources Gallery in Houston, TX. I also have had relevant experience in museum/gallery administration, having worked primarily in installation and collection management for six different institutions, most notably the Walker Art Center.
